## PROPOSAL FOR ESTABLISHING A UNIVERSITY COMMERCIAL BANK AND A PUBLIC SCHOOL HOLDING COMPANY

The economic success of a nation is based on each individual business and job while **Agenda 2063** emphasis the need to mobilize domestic resources for the attainment of sustainable development and collective prosperity. Therefore, this is to propose that Ministry of Education and Sports,

- 1. Establish a Public School Holding Company (PSHC) which owns all public primary schools, secondary schools, universities, vocational schools and technical schools with a mandate of creating more public schools, manufacturing all scholastic materials, managing all public schools, manufacturing office stationary, renovating all public schools and creating commercial hostels so as to gradually eliminate donor dependency, tame miss-management of education funds, to reduce the cost of education and to create a pool of subsidizing public schools promptly and efficiently.
- 2. Coordinates all universities in Uganda (Public and Private) to collectively establish a University Commercial Bank (UCB) were all students pay their tuition on condition that UCB finance commercial projects of universities that create jobs for graduates.

All students in public schools should deposit their fees and tuition on the bank account of **PSHC** which is hosted by **UCB** on condition that **PSHC** sales ten percent (10%) of its shares to the National Private Educational Institution Association (**NPEIA**) for oversight. The **PSHC** should be compete with suppliers of government office stationary. The land titles of all public schools should be transferred in the name **PSHC** for protection against encroachers of public school land. All government funds of facilitating education should be channeled through **PSHC** so as to improve on corruption checks and balances.

Hope this proposal meets your visionary leadership in the best interest of creating more jobs for graduates and generating more taxes for government because public sector policies are articulated by private sector projects.
