PROPOSALS BY DITHREE GROUP (D3G) PRIVATE COMPANY

I acknowledge receipt of your letters, two dated 7th August, 2024 of Ref: D3G-40/25/8-24, D3G-42/25/8-24 and another, dated 12th February, 2024 of Ref: D3G-11/12/2/24 in which you proposed to;

- i. Mobilize domestic revenues from adverts on roads, through violation of police notices, by fining truck drivers for tying animals/birds on trucks in a cruel painful manner; and
- ii. Create Public-Private Agencies for thinking and planning, auctioning spoilt Government Assets, manage Employee Awards, Whistle-Blowing and to fine Members of Parliament for failing to attend Parliamentary Sessions.

Whereas this Ministry appreciates your efforts to improve effectiveness and efficiency in service delivery, the above proposals are already mainstreamed within current Government operational frameworks such as; Public Finance Management Act (PFMA), 2015, National Planning Authority (NPA) Act, 2002, Local Government Act (Cap 243) and Road Traffic and Road Safety Act, 1998, among others. Secondly, the proposal to create Public-Private Agencies is not in line with the ongoing Rationalization of Government Agencies and Public Expenditure (RAPEX).

The purpose of this letter, therefore, is to inform as above. You are also advised to liaise or work with the relevant Government Ministries, Departments and Agencies to ensure improvements in service delivery.

CREATE A PUBLIC - PRIVATE AUCTIONING AGENCY RE:

Reference is made to your letter dated 7th August 2024 on the above subject.

The Authority noted from your letter the proposals to create a Public-Private Auctioning Agency (PPAA) and to lease government vehicles on a five-year contract from authorized dealers.

The Authority advises you as follows:

- 1. The Authority as the principal regulatory body of public procurement has the mandate of monitoring compliance of Procuring and Disposing Entities (PDEs) to the provisions of the PPDA law. It is not within the Authority's mandate to handle the proposals highlighted in your letter.
- 2. The proposals should be handled in accordance with the Public Private Partnership (PPP) Act. 2015.
- 3. The company should liaise with the PPP Unit in Ministry of Finance Planning and Economic Development which will assess the proposals' suitability based on the provisions of the PPP Act and the Regulations. The Unit is responsible for screening, analyzing, appraising, monitoring and evaluation of all development projects undertaken by way of PPP and is also responsible for facilitating the implementation of PPP initiatives as a vehicle for delivery of services and development on behalf of the Government of Uganda.

The Authority has given this guidance based on the information provided.
