mind on a full state of identifying African Solutions jealously, on principle and by conviction outside the square because a successful society is based on the skills and values of its leadership. The economic success of a nation is based on each individual business and job. Leadership is the process of social influence where one person mobilizes the aid or support of others in the accomplishment of a common goal or task. While development is the changing of society with effects to its norms, values, institutions, attitude of its people, methods of production and the way in which resources are distributed for the attainment of total the transformation. There is also need for Churches Schools and Mosques to start teaching and preaching to teenagers about the disadvantages of having sex before clocking eighteen years of age or before completing education and the beauty associated with having sex after completing education or getting married.

- a) On 02 August 2024 Dithree Group (**Now Triple D Empire**) proposed to government under Ref: D3G-45/2/8/24 as per the attached copy that it would be better for the empowerment funds like PDM, Myoga, Ntandikwa etc. to be disbursed as a sixty percent (**60%**) top up loans to strictly Gender Balanced Investment Clubs (**GBICs**) with bank accounts that had operated for at least six months (**6mth**) so as to spray the risks, benefits and oversight hence grooming the youth into potential investors and entrepreneurs instead of the current format which is more of a patronage of adding more tax burden on Ugandans, more debt burden on government and more frustration on the recipient.
- b) On 07 August 2024 Dithree Group (**Now Triple D Empire**) proposed under Ref: D3G-41/25/8/24 as per the attached copy that Inter-Religious Council of Uganda work with the IGG, Transparency International, PSFU and the Auditor General to conduct an Annual Integrity, Competent and Faithful Award for Leadership and Marriage (**AIC&FALM**) of employees who have worked with a government organizations or a private company for years without a dent of corruption and faithful couples who have been together for years without separating.
- c) On 28 May 2024 Dithree Group (**Now Triple D Empire**) proposed under Ref: D3G-34/28/5/24 as per the attached copy that Political Parties should collectively write a book about the good and bad of all former presidents of Uganda and use the accrued funds to build an Inter-Political Political Library (**IPPL**). The **IPPL** should annually publish an Africa leadership book among others political aspects.
- d) On 04 October 2024 Dithree Group (**now Triple D Empire**) proposed to government under Ref: D3G-59/4/10/24 as per the attached copy about the need to enact an impartial simple defilement law which punish both the teenage girl who indulge in sexual intercourse (**fornicate or trades in sex**) for material or monetary gains and the male who provides the material or monetary in exchange for sex because given the rate of youths on simple defilement cases in prison for years were the rate of teenage girls involved in sexual immorality is extremely high because of the blank cheque teenage girls have to indulge in sexual immorality (**fornication**) as they please. Sexually active teenage girls as young as ten years (**10 years**) indulging in sexual immorality as a result of the environment they are brought up in were also some of their parents permit them to seduce men for material or monetary gains (**prostitution**) not for getting peer pressure. The impartial law will act as a scare crow for teenage girls to an extent that it should state that any teenage girl who decides to have sex for material, for pleasure or for money before clocking eighteen years consents to simple defilement hence subject for punishment by law and the parents who allow their children to indulge in sex for material gains before clocking eighteen years of age commit an offence of promoting simple defilement.
- e) On 07 August 2024 Dithree Group (**Now Triple D Empire**) proposed to government under Ref: D3G-43/25/8/24 as per the attached copy to create a Public-Private Auctioning Agency (**PPAA**) which sales all spoilt/old government machines, devices, vehicles, equipment and gadgets to the

public and use the accrued funds to supplement the servicing of the national debt because government organizations are littered with spoilt/abandoned machines, devices, vehicles and equipment countrywide which can fetch billions of shillings if well auctions. And also lease vehicles on a five-year contract from authorized dealers just like big companies do because the cost of buying spare parts, under valuing items for auction and buy new vehicles is extremely high.

- f) On 12 February 2024 Dithree Group (**Now Triple D Empire**) proposed to government under Ref: D3G- D3G-11/12/2/24 as per the attached copy that the Auditor General (**AG**), Uganda Revenue Authority (**URA**) and Inspector General of Government (**IGG**) work with the Bankers Association to collectively Inform voters to identify corruption properties, corruption accounts or corruption assets and contact the IGG in attention to Transparency International (**TI**) to help them get twenty percent(**20%**) commission of the recovered property, account or asset.

Many proposals have so far been submitted to various government organizations, companies, NGOs and after developing our website, all proposals will be uploaded to enable your voters/congregants to follow up because Africa priorities are misplaced. For example, why it is that government has put in place mechanism of recouping **BILLIONS** of Grow Funds borrowed from World Bank to lend to women and failed to put in plane measures of recouping **TRILLIONS** of Ntandikwa funds, youth livelihood, Myoga Funds etc. borrowed from taxpayers. **Do foreign interests take precedence over national interests?** The only way African countries can guaranty development is by **STRICTLY** appointing and voting professionally competent ministers/politicians and technocrats/civic servants of integrity with better remuneration **ON CONDITION** that they take full responsibility of the failure or the success of the organization, ministry or department because politicking for personal interests is failing many development projects yet political will plays a major role in propelling national interests.
