MINISTRY OF SCIENCE, INNOVATION AND TECHNOLOGY in conjunction with the Ministry of ICT mobilize Ugandans to develop any scientific or technological innovation / invention using their own money on condition that you meet the coats of patenting and commercializing their innovation or invention in exchange of twenty percent (20%) shares of the innovation/invention which you will eventually sale to the public after patenting and commercializing so as to recoup your investment with profits because education gives access to knowledge but it takes wisdom to harness knowledge. Therefore, education without natural ability is as good as plain chips because knowledge has no value except gains from its applications. Most Innovation funds end up in the pockets of corrupt political leaders and civil servants who only innovate corruption syndicates. Innovation funds meant for promoting scientific and technological innovation end up in the pockets of corrupt civil servants or political leaders.

3. AFRICA OIL, AIRLINE & MINERAL CORPORATION

Uganda and China mobilize and coordinate all African countries to Collectively create an African Oil and Mineral Exploration and Extraction Company (AO&ME&EC) were China holds twenty percent (20%) shares of the AO&ME&EC on condition that the AO&ME&EC establish itself in each African country and sale ten percent (10%) shares to the private sector of each African country so as to protect the interests of Africa and China because significant development that has cropped

up within the short length of time China has been in Africa as compared to the long length of time Europe and America have been in Africa. Also Partner with China on building airline capability of each African country on condition that China provides its manufactured Comac C919 commercial plane to each airline in exchanges for shares in an African airline. Alternatively, UGANDA NATIONAL OIL COMPANY mobilize and coordinate all state-owned oil companies throughout all African countries to collectively create an Africa Oil Exploration and Extraction Company (AOE&EC) and sale ten percent of the AOE&EC shares to BRICS Business Council. While NATIONAL WATER AND SEWERAGE CORPORATION partner with Umeme Uganda Limited on creating mini-power plants for sale to the public.

4. PUBLIC-PRIVATE AUCTIONING AGENCY

Government create a Public-Private Auctioning Agency (PPAA) which sales all spoilt/old government machines, devices, vehicles, equipment and gadgets to voters and then use the accrued funds to supplement the servicing of the national debt because government organizations are littered with spoilt machineries, devices, vehicles and equipment countrywide which can fetch billions of shillings if well auctions. And also lease vehicles on a five-year contract from authorized dealers because, the cost of buying spare parts, under valuing vehicles for auction and buy new vehicles is extremely high.

5. LEADERSHIP FOR TAMING CRIMINAL ACTIVITIES, FOREIGN AID AND DOMESTIC VIOLENCE

Religious institutes and Religious institutions mobilize your congregants / voters to create Gender Balance Investment Clubs (GBICs) for substituting foreign aid with surplus taxes, borrowing for consumption with saving for production, poverty with income and unemployment with opportunities so as to tame the causes of domestic violence, criminal activities, teenage marriages and social exclusion because teamwork makes a dream to work. And also recommend Triple D Empire to coordinate your congregants / voters on registering their clubs, acquiring a logo, a stamps, applying for a TIN, book a co-working office space with Wi-Fi, a meeting room with a presentation screen or a virtual office with reception services so as to attain capacity of running this GBIC program on radio stations and subsequently develop an online system which mobilize and coordinate Africans throughout the continent to enter into investment partnerships, joint ventures, business mergers, investment clubs etc. for exporting, manufacturing, importing, bidding, farming, supplying, mining, financial inclusion, commercial transport, real estate, health services, fashion design, education services, restaurant, technical services etc.

6. AFRICAN EQUITY INVESTMENT AND TRADE TOUR

SADC, ECOWAS, ECCAS, EAC and COMESA collectively set up an African equity investment corporation (AEIC) which identifies potential African own companies and buys in some shares with a prospect of helping such companies to enter all markets of African countries. Private Sector Foundation Uganda (PSFU) and Uganda Investment

Authority (UIA) collectively invite African billionaires from all African countries to create an Africa Billionaire's Corporation (ABC) which partners with African governments on investments. While AFRICA EXPORT AND IMPORT BANK, KAMPALA CITY TRADERS ASSOCIATION and UGANDA EXPORT PROMOTION BOARD collectively invite traders for an Africa Intra-Trade Opportunities Tour (AITOT) of promoting AFCFTA. The chairperson of African Union should be the patron of leading AEIC to all African states so as to protect African interests' jealously on principal and by conviction. And the AEIC should secure operating funds from member states. But whenever KACITA is demonstrating against the increase of taxes it should also pressure government on eliminating the corruption tendencies highlighted in the budgetary leak and if it is true that President Museveni wants traders to migrate to manufacturing yet trading is their calling, he should first sack the minister for Trade and close the ministry of trade because manufactures and traders complement each other in the business chain.

7. INTEGRATED SAVING SYSTEM WITH A NEXT OF KIN AGENCY

Carrefour market, Stanbic bank UAP Old Mutual Insurance, MTN, National Social Security Fund, National Water and Sewerage Corporation, Uganda Revenue Authority and Umeme/UEDCL create an integrated system which enables people to indirectly save five (+/-) percent for tax, land, insurance, education, social security or capital whenever they pay their Umeme/UEDCL bills, withdraw money from their Stanbic bank account, buy something from Carrefour market, withdraw money from their MTN mobile money, pay NW&SC bills or receive salary from their employers so as to revolutionize the saving culture because you enjoy a wider outlet network and the largest market share in Uganda. There is also need for insurance companies to advocate for the creation of a Next of Kin Agency (NoKA) as detailed herein. A subscriber will have to open up an account with URA, UAP Insurance or NSSF then sign up with Umeme/UEDCL, Stanbic bank, NW&SC, Carrefour market or MTN to secure their security. The integrated system should automatically deducts a percentage at the expense of the subscriber and emit it direct on the subscriber's saving account. The system should have both saving options and percentage options to enable the subscriber to make their choice. The tax saving scheme will enable people to save for their trade license etc. and it will work as a collateral for clearing tax obligations. While the Capital Saving Scheme will necessitate Banks to create a provision of a Flexible Deposit Account. Whereas insurance provide a guarantee of compensation as much as social security provides retirement sources of income, MOST parents who save for their children's future are facing a profound challenge when they die simply because most of the next of kin convert the insurance fees for their personal interests at the expense of the beneficiaries which cause the deceased's to toast and turn in their grave hence making the insurance close to useless for MOST of our friends and relatives have a high deficit of integrity to an extent that they are preying on our properties and assets even when we are still alive. Therefore, there is also need for the insurance companies (through your umbrella body) to partner with

the Administrator General (Government) on creating a Next of Kin Agency (NoKA) which represent the deceased's insurance interests.

8. HEALTH FACULTY HOLDING COMPANY

International Medical Group works with Ministry of health to mobilize and coordinate both public and private hospitals to collectively create a Public-Private Medical Fund (PPMF) for lending to hospitals, medical drug manufactures, health centers and medical equipment manufactures so as to gradually eliminate donor dependency while MINISTRY OF HEALTH set up a Public Health Faculties Holding Company (PHFHC) which owns all public health facilities with a mandate of creating more health facilities, manufacturing medical facilities, managing all public health facilities and renovating all public health facilities. All patients in public clinics, hospitals and centers should pay their medical bills on the bank account of PHFHC so as create a strong pool of subsidizing public health facilities efficiently on top of gradually eliminating donor dependency on condition that the PHFHC is also mandated to compete with other importers/export medical equipment and medical drugs. The PHFHC should sale ten percent (10%) shares to the Uganda National Private Hospital Association for purposes of sharing the responsibility of health service development with the private sector. All government funds of facilitating health should be channeled through PHFHC so as to improve on corruption checks and balances. The PPMF should be operated with a prospect of graduating growing into a medical commercial bank and host the account of PHFHC

9. AFRICA'S OPERATING SYSTEM, SEARCH ENGINE AND APP STORE

National Information and Technology Authority partners with Huawei Uganda Limited on mobilizing and coordinating all Universities in African counties to collectively develop an African computer and phone operating system, search engine and app store which are compatible with the current dominate operating system and search engine. Uganda Prisons Service (UPS) and Uganda Police Force (UPF) substitute manual data entry by appointing Huawei to supply reception computers countrywide with a centralized data base on condition that you pay them in installments every financial year because such brands can't be stolen by the staff to sale them on an open market for lack of demand. Prisons and schools shift from the rudimentary banging bells by installing solar powered ring bells. MTN Uganda mobilize telecom companies throughout African to collectively appoint Huawei on developing an Africa App Store for smart phones and to develop an alternative internet search engine for Africa so as to avoid a situation where the current hosting nations hold Africa at ransom. While UGANDA PRISONS SERVICES partner with spinning companies to add value on the cotton you plant instead of exporting it as raw materials and also partner with abattoirs on adding values on hide and skins instead of exporting them as raw materials.

10. MODEL OF AFRICA MULTIPARTY DISPENSATION

African heads of states (Presidents) swap presidency with other African countries so as to fast tract African federation and also surrender the title of President to the Chairperson of African Union in adoption of the govern title were for example, the Ugandan president should take over South African presidency, the Egyptian president takes over Uganda presidency, the Kenyan President takes over Egypt presidency, the Nigerian President takes over Kenya presidency, the Rwanda President takes over Nigerian Presidency etc. on a rotational basis but there is need for the Chairperson of African Union to be nominated from the sitting Secretary Generals of Africa's Blocs like SADC, EAC, ECOWAS etc. so as to fast tract Africa federation. Political parties in African countries create an Inter-Political Party Library (IPPL) in the best interest of writing Africa's narrative. The IPPL should annually publish an Africa leadership book among others political aspects highlighting the good and bad of all former African presidents and use the accrued funds to build an Inter-Political Party Library (IPPL). In the modern setting of Africa's multiparty dispensation and gender equality, it should be a policy for the presidential candidate who scores second to automatically becomes the head of government business (Prime Minister) and the one who scores third to automatically become the speaker of parliament were all political parties are represented in the national election body on top of having crowd funding bank accounts were their supporters can donate using mobile phones on condition that the male leaders (across the board) appoints a female deputy/vice without compromising professional competence and the female leader should as well do the same. Until the western countries and their allies accept that according to the law of nature democracy and autocracy have to co-exist based on the fact that God created the world on a two dimension (good and bad, day and night, God and Satan, Strong and weak, male and female etc. to balance the equation or to complement each other) the world will never be at peace with America's selfish attitude of dominating the world at the expense of the dominated. Leaders have to be like parents who derive joy from the welfare of their children and that's why a dictator who protects national interests at the expense of foreign interest is better than a democrat who protects foreign interest at the expense of national interest because the imperialist attitude of America and its allies to sanction countries and to overthrow governments with an excuse of promoting democracy is grooming more dictators globally a trend which is putting the opposition political parties between a rock and a hard place. 11.PRIVATE THINKING AND PLANNING AGENCY

Government mobilize all Private universities and Public universities to collectively create a Private Thinking and Planning Agency (PT&PA) which Fine-tunes policies and or recommends policy formulation to all government organizations. Drafts an alternative National budget for government. Recommends social and economic development strategies to government. The PT&PA source of funding should derive from membership subscriptions, constancy fees from private companies, diplomatic missions, government organizations and none-government organization. The PT&PA should be headed by the vice chancellors on a rotational basis of one year while the university lecturers and professors should be the employs of PT&PA on a contract basis. The challenges of inability to plan, unsuccessful planning or inadequate planning are brought about by planers who don't have planning callings, enough planning skills, planning values, planning background, planning education or who put personal interest before national interest. While the major challenge of policy formulation and implementation is mainly the overlap between policy formulation and implementation on top of lack of analytical coordination of government organization prior to policy formulation.

12.AFRICAN MILITARY EQUIPMENT AND CIVILIAN PROTOTYPE

MINISTRY OF INDUSTRIES mobilize and coordinate embassies of all African countries in Uganda to direct all public universities in their home countries to collectively design prototypes of Africa's tipper, laptop, missile, bus, plane, gun, phone helicopter, bike, tank, trailer etc. and then each of the countries partners with its private sector companies to manufacture/produce two or more spare parts, software and semi-conductors of the tipper, laptop, missile, bus, plane, gun, phone helicopter, bike, tank, trailer etc. on condition the Uganda assembles the tipper, laptop, missile, bus, plane, gun, phone helicopter, bike, tank, trailer etc. and sale them to governments of all African countries - Deal. Uganda People's Defense Force (UPDF) mobilize and coordinate all African countries to collectively create an African military equipment and Weapon Manufacture (AME&WM) on condition that each African country produce two or more parts of the equipment and Weapons and then delegate one or two African countries with the responsibility of strictly assembling the equipment / Weapon and sale the to all African countries. And it should be a policy for all L.C.1 defense secretaries countrywide to automatically become agents of JATT so as to improve defense and security intelligence efficiency. The AME&WM should sale ten percent (10%) shares to the government of Russia, ten percent (10%) shares to the government of Iran and ten percent (10%) shares to the government of China so as to transfer the technology required in the production of such equipment and weapon. This will gradually create jobs in African countries on top of promoting Africa's military might.

13.DISBURSE EMPOWERMENT FUNDS AS TOP UP LOANS FOR GBICs

Since government is obliged to invest in sectors which move capital into taxable goods and services, it would be better for the empowerment funds like PDM, Myoga, Ntandikwa etc. to be disbursed as a sixty percent (60%) top up loans to strictly Gender Balanced Investment Clubs (GBICs) with bank accounts that had operated for at least six months so as to spray the risks, benefits and oversight hence grooming the youth (citizens) into potential investors and entrepreneurs instead of the current format which is more of a patronage that adds more tax burden to tax payers, more debt burden on government and more frustration on the voters. Borrowing for consumption and importing for consumption in an environment where tax rates raise as corruption increase is disabling the natural abilities of Africans to apply our minds on a full state of identifying African solutions hence increasing foreign aid and neo-colonialism tendencies.

14.HOST GLOBAL LENDERS TO MERGE STATE BANKS INTO AN AFRICAN BANK

- Uganda government restructure UDC to be the SOLE Investment and Development arm of government which **HOLDS ALL SHARES** of Public Enterprises on behalf of the line government agencies and ministries on condition that **ALL** government investments with **ANY PRIVATE COMPANY** in Uganda and outside Uganda is channeled through UDC so as to create a Sovereign Investment and Development Fund (SI&DF) which move capital into goods and services which creates more taxes, more jobs and more wealth. UDC should borrow for **EMERGENCY PRODUCTION** of recapitalizing straggling privates companies or industries under the supervision of both Ministry of finance and Ministry of Trade on condition that UDC subsequently re-sale the acquired share to the public at a profit so as to enable it meet its investment strategies on time instead of **JUST** waiting for government inadequate funding which delays to be released. UDC to sale **SOME OF THE SHARES** it holds to the public with a prospect of raising capital for buying straggling companies and industries to restructure them and re-sale majority of the shares to the public on condition that UDC works with Capital Market Authority on engaging all commercial banks to mobilize their customers to apply for salary loans of buying such shares from UDC so as to protect domestic entrepreneurs, employs, domestic investors and to create more investment opportunities for Ugandans on condition that the law is amended to allow the Auditor General to audit **ANY PRIVATE COMPANY** were government holds less than fifty percent (50%) shares (**OR ANY SHARES**).**
- AFDB mobilize SADC, ECOWAS, EAC and COMESA collectively set up an African equity investment corporation (AEIC) which identifies successful African own companies and buys in some shares with a prospect of helping such a company to enter all markets of African countries. The chairperson of African Union should be the patron of leading AEIC to all African states so as to protect African interests' jealously on principal and by conviction. And the AEIC should secure operating funds from member states.**
- Bank of Uganda and Ministry of Finance should host both New Development Bank and World Bank in your headquarters so as to leverage expertise and competition**

from the two lenders so as to simplify borrowing terms and condition in the best interest of Uganda's economic development.

- **Africa Development Bank (AFDB)** mobilize all state own commercial banks throughout African countries to merge into an Africa Commercial Bank (ACB) and sale ten percent shares of ACB to BRICS Business Council develop so as to fast track the globalization of the Pan – African Payment and settlement system (PAPSS) on condition that also the New Development Bank (NDN) of BRICS+ should be represented in the Central Banks (Regulator) of African Countries hence lead to Africa's Monetary Currency Printing System.
- **MINISTRY OF EDUCATION AND SPORTS**, coordinates all universities in Uganda (Public and Private) to collectively establish a University Commercial Bank (UCB) where all students pay their tuition on condition that UCB finance commercial projects of universities that create jobs for graduates and Makerere University Business School (MUBS) should be instrumental on the establishment of the UCB project.
- **Uganda Institute of Banking and Financial Services** promote cashless economy or sensitize the public under corporate social responsibility about handling and storing monetary notes because some people like Bodaboda rider, market vendors, taxi conductors etc. fold money like waste papers and stuff them in their pockets a trade which cause the legal tender to wear out within a short length of time. The folding and stuffing also cause them to lose their money as it drops off to the ground without their knowledge whenever they are pulling it out of their pockets or pushing it in.

The fact that teamwork makes a dream to work, UIDC through its SI&DF will be able to operate without government funding to gradually tame FOREIGN AID and HEAVY BORROWING which are disabling the natural abilities of Ugandans from applying our minds on a full state of identifying PRACTICAL SOLUTIONS for our challenges. The Public Enterprises should include but not limited to Housing Finance Bank, Kiira Motors Corporation, National Housing and Construction Company, National Social Security Fund (Uganda), National Water and Sewerage Corporation, Posta Uganda, PostBank Uganda, Pride Microfinance Limited, Uganda Air Cargo, Uganda Broadcasting Corporation, Uganda Development Bank Limited, Uganda Development Corporation, Uganda Electricity Distribution Company Limited, Uganda Electricity Generation Company Limited, Uganda Electricity Transmission Company Limited, Uganda Energy Credit Capitalization Company, Uganda Hotel and Tourism Training Institute, Uganda Industrial Research Institute, Uganda Airlines, Uganda National Oil Company, Uganda National Pipeline Company, Uganda Refinery Holding Company, Uganda Standard Gauge Railway etc. But commercial Banks, ICT Ministry and telecom companies collectively promoting smart phone ownership, national ID card acquisition and ICT infrastructure so as to create an environment which extend financial inclusion access points to the farthest end of the country that creates more jobs, increase purchasing power, generate more taxes and create more wealth. The time is ripe for government to think outside the square and to adopt a culture of Mobilizing Domestic Resources in the best interest of fostering a private sector led economy because the degree at which government thinks within the BOX at the expense or detriment of its citizens can be judged by how it subsidizes consumption

instead of production, how it force companies to pay for postal boxes which are almost useless, how it copies outside and pest inside, how it increases taxes without investing in sectors which move capital into taxable goods and services on top of taming corruption, how it borrows for projects with encumbrances that stall the utilization of the loan as it attracts interest, how it protects foreign investors instead of domestic investors etc. a trend has led the youths to adopt a culture of using more of their hearts on pursuing small public opinion dreams for survival instead of using more of their brains to pursue big of purpose for living dreams to thrive.

15.AFRICAN UNIVERSITY GUILD PRESIDENTS AWARD CEREMONY

INTER-UNIVERSITY COUNCIL FOR EAST AFRICA Organize an Annual African University Guild Presidents Award Ceremony (AAUGPAC) of articulating Agenda 2063 Objectives through mobilizing domestic resources for social programs, innovations projects, teamwork initiatives, business models etc. which propel collective prosperity, visionary leadership, sustainable development, professional competence, social responsibility and economic Independence because leadership is the process of social influence where one person mobilizes the aid or support of others in the accomplishment of a common goal or task. And also invite International Business Speaker Vusi Thembekwayo, Pan-African Law Professor P. L. O. Lumumba, the Richest African Aliko Dangote, the Chairperson Anti-Sanction Movement, Rutendo Matinyarare, Pan-African Brian Kagoro and the Honorable Minister of Education and Sports to address the AAUGPAC participants on how Pan-Africanist rise by lifting Africans with a sense of direction, a sense of belonging and a sense of dignity because handouts, lip service and patronages is disable the natural abilities of Africans. The AAUGPAC should rotation throughout African countries to spar intra-Africa tourism, investment, intellectual capability, exploration, trade, talent and open with a song ALL WE NEED IS HERE IN AFRICA by P.J Powers and close with BORN IN AFRICA by Bongole Philly Lutaaya.

16.PRIVATE CAPITAL FOR PUBLIC FACILITIES:-

- **Wavah Group, Simba Group, Mulwana Group, Mukwano Group, Ham Group, Roofings Group, BMK Group, Rupeleria Group, DFCU Group, Madhvani Group and Alam Group finance the construction / renovation of Police Barracks/stations, National Roads, District headquarters, Feeder Roads, Prison Barracks/stations, Ministry Headquarters etc. on the basis of Build, Own, Operate and Transfer (BOOT) because a good number of barracks, roads, offices, and stations are in a sorry state yet private companies are looking for investment opportunities. The Police, District Prison or ministry should give you a blueprint, the land and a budget of the building or road they want you to finance on condition that you manage the building or road for as long as it takes for you to recoup your investment were government pays you on a monthly basis as rental fees or the road users pay you on a daily basis as road toll fee so as to use private funds for public facilities because government is limited with resources of constructing new/renovate yet there is a lot of**

private money slashing around. But Uganda Revenue Authority should capitalize on rented government office space to private users.

- Buganda Kingdom appoint Symbion Uganda Limited to design a master plan of Lubili land and Kabaka Lake then invite each clan to finance the construction of a portion of the master plan. The accrued return on investment should be used to construct a Commercial Clan Headquarter (CCH) for each clan.
- Ministry of works and Ministry of foreign affairs collectively mobilize and coordinate all embassies of African countries in Uganda to collectively acquire land and invite local companies like insurance companies and domestic billionaires like Kwagalana club to finance the construction of an Embassy Union Tower (EUT) on a Build, Own, Operate and Transfer basis (BOOT) so as to accommodate all African embassies under one roof. And also invite private companies or domestic billionaires to buy land outside Kampala (i.e. in Wakiso district, Mukono district, Mpigi district etc.) and construct a particular government building in exchange (swap) of the existing building on condition that the constructed building bigger and better than the one to be swapped. The trend of swapping will reduce the volume of government employees and government clients who contribute the traffic jam because government is the biggest spender as in public sector led economy instead of a private sector led economy.
- Housing finance bank and ministry of land, housing and urban development collectively facilitate National Housing Construction Corporation to partner with Association of Real Estate Agent on buying outdated buildings on the main road and to compensate slum dwellers and then resale the land to potential developers in the best interest of fostering smart cities.
- Roofings Group Uganda Limited, Plascom Paint Uganda Limited, Tororo Cement Uganda Limited, Kampala Cement Uganda Limited, Steel and Tube Uganda Limited, Uganda Clays Limited, Sadolin Paint Uganda Limited, Steel Rolling Mill Uganda Limited, Uganda Baati Limited and Biplous Uganda Limited collectively facilitate the BOOT basis campaign as highlighted above so as to increase the supply and demand of your products.

It is unfortunate that in 2021 prisoners of Ntwetwe, Luzira, Namalu etc. including suspects at Jinja road police, CPS, Wandegaya police etc. sleep on top of each other as benches of Matooke due to limited space to accommodate the large influx of suspects and prisoners as junior prison and police officers sleep in decapitated or grass roofed houses. While some district offices sit under the tree. The fact that public sector policies are articulated by private sector projects, the BOOT projects will move enormous capital into goods and services which create jobs, generate taxes and improve the welfare of uniform officers hence government hit two birds with one stone because wealth is created.

17. APPOINT BRISC ON RECIPROCATION AND CHINA ON CONSTRUCTION

AFRICAN UNION appoint China to construct airstrips, install solar panels, construct railways, install wind turbines and to construct roads on all Africa's no

man's land borderlines on a basis of Build, Own, Operate and Transfer (BOOT) so as to tame illicit porous border trade. While BRICS Business Council help countries like Palestine, Southern Sudan, Venezuela, Mali, Cuba, Somalia, Lebanon, Ethiopia, Syria, DR. Congo, North Korea, Chad, Afghanistan, Libya, Yemen etc. to develop a Barter Trade, Sports Games and Trade Reciprocation program which spar international Investment and also work with African countries to transact international trade so as to attain economic independence that leads to political independence.

18. ALLOW PRIVATE FUNDING OF DUCTS AND ROADS:-

Government allow willing organizations, people and companies to finance the construction of the feeder roads which leads to their offices, homes, factories etc. on condition that they apply to the town council, city authority or municipal council in attention to the Uganda National Roads Authority requesting to finance a feeder road under corporate social responsibility within their jurisdictions. The town council, the city authority or the municipal council should approve the road contractor on top of supervising the road works at the expense of the applicant. MTN Uganda, NWSC Uganda, Umeme Uganda, Airtel Uganda etc. work with government on constructing an all in one road ducts for cables, sewage and pipes so as to stop routine breaking of the roads. But Uganda National Roads Authority (UNRA) empower domestic road contractors to build capacity by ensuring that it is a policy that one of the prerequisites for a domestic company to win a contract is by hiring engineers who match or complement the competence of Chinese engineers so as to pass on the expertise to Ugandan engineers. And this should as well apply to all engineers of town councils, city authorities and municipal councils who repair roads. While MTN, NATIONAL WATER & SEWERAGE CORPORATION, UMEME UGANDA LIMITED, AIRTEL ETC. to work with government on constructing an all in one road ducts for sewage, cables and pipes so as to stop routine breaking of the roads.

19. LEADERSHIP INTEGRITY, MARRIAGE, COMPETENT AND FAITHFUL AWARD

Inter-Religious Council of Uganda, conduct an Annual Integrity, Competent and Faithful Award of Leadership and Marriage (AIC&FALM) for employs who have worked with a government organizations or a private company for years without a dent of corruption and faithful couples who have been together for years without separating. People of integrity often engage in actions that benefit society through voluntary work, activism and ethical business practices among others which contributes positively to their communities hence reduce stress and inner turmoil. Faithfull gives society a sense of trust, confidence and certainty. While professionally competent people have the necessary knowledge and skills to perform their jobs effectively in the best interest of society. But since some corrupt people are reappointed before the elapse of ten years on top of advocating for them, every last week of the month all churches, shrines and mosques countrywide should dedicate the corrupt people to God and to the ancestors. The AIC&FALM will gradually restore the spirit of public interest and also promote the culture of successful marriages

because scripture states that if you wait for the dust of revolution to settle, you will never sow the seeds of change. While Mahatma Gandhi said that the world has everything to meet everyone's needs but has nothing to satisfy anyone's greed.

20. RECYCLING AND RECIPROCATING FOR CLIMATE CHANGE

- **NATIONAL FORESTRY AUTHORITY (NFA)** plant rubber trees in kalamoja region of exporting rubber to India and Japan as raw materials for making tyres of vehicles and bikes Ugandans import from them so as to promote trade reciprocation and to mitigate climate change. And it should be a policy for all forests and wetlands to have a military detach which protects them from encroachers.
- **MINISTRY OF WATER AND ENVIRONMENT** partner with the private sector through a Public-Private Partnership to create a Solid Waste Investment Agency (SWIA) which **STRICTLY** buys value added products or services from any company or SMEs which adds value on solid waste for recycling and then re-sale the products or services to the open market so as to propel demand and supply that creates more jobs and taxes in the best interest of fostering collective prosperity, environmental protection and sustainable development.
- **NATIONAL ENVIRONMENT MANAGEMENT AUTHORITY (NEMA)** mobilize tire importers to plant rubber trees for exporting rubber to India and Japan as raw materials for making tires of vehicles and bikes which Ugandans import from them so as to promote trade reciprocation and to mitigate climate change.

Solid waste management, forest conservation, inadequate infrastructure and informal waste disposal practices is at the center of government challenges due to limited financial resources and limited political will, yet a lot of private funds are chasing for opportunities. And as such, all companies or SMEs which adds values for recycling should **STRICTLY** pick their solid waste from either the gazetted dumping sites or establish their operation at the dumping site on condition that they are certified by SWIA to avoid a situation of manipulating SWIA objectives. The SWIA Partnership should **STRICLY** be done with companies or SMEs which are owned by Ugandans on condition that SWIA outsources the management and technical team from abroad but deputized by Ugandans so as to pass on expertise or professional competence to Ugandans from foreigners. SWIA should as well be mandated to develop adequate solid waste infrastructure on top of regular public education about the formal solid waste disposal practices.

21. INTERNATIONAL INVESTMENT CORPORATION

National Social Security Fund (NSSF), Uganda Development Corporation (UDC), Uganda Manufacturers Association (UMA) and Private Sector Foundation Uganda (PSFU) collectively set up an International Investment Corporation (IIC) with a mandate of investing in foreign ventures which rakes foreign currencies in Uganda, real estate and capacity building of creating wealth that fosters economic independence.

22. STUDENT'S FUTURE FUND FOR CAPITAL

UGANDA NATIONAL STUDENTS ASSOCIATION partner with commercial banks and Telkom companies to conduct an annual science and artist award for the best students and graduate and also mobilize Asian students, Europe students, Middle East students, African students and America students in Uganda to write a poem on how the White Pig and the Black Monkey can co-exist with respect and publish them into a poetic book on condition that the accrued funds from the sale of the book are used for UNSA development. Partner with MTN Uganda and Stanbic bank to conduct an annual science and artist award for the best students and graduate. Invite insurance companies and commercial banks to create a Student's Future Fund for Capital (SFFC) which any school dropout or graduate can use to start a business or to go for further studies so as to enable graduates who fail to get employment and dropouts who fail to graduate create their own business. The SFFC should be deducted from the student's fees and tuition by a certain percentage right from primary school throughout vocation/university. I suspect that some graduates who failed to secure jobs and capital yet their parents scarified a lot to raise their fees and tuition are psychologically tortured to an extent that they come to a point of wishing that their parents saved the fees and tuition as future capital even if there is no guarantee that a business cannot fail.

23. AFRICAN SEED BANK AND TO EMBARK ON INDIGENOUS FARMING

Whereas GMOs (Genetically Modified Organisms) provide a certain degree of food security because of its high yield and probably its nutritional values, there are speculations that GMOs are promoting cancer and drug resistance on top of neo-colonialism as a result of lack of self-propagating seeds or sperms. Therefore, African countries collectively create an African seed bank and sperm bank which also promotes indigenous agricultural and livestock farming so as to tame the effects of GMOs. According to me Uganda has the best indigenous Avocado with a great test as compares to those of America and Europe but it is sold cheaply on the locally market and it is gradually disappearing at the expense of the imported Avocado. The speculations also highlights that America, Europe and their allies have created a seed bank and a sperm bank of all African spices and they have a clandestine move of recolonizing African countries through agricultural and livestock products (GMOs) which are not self-propagating.

24. ESTABLISH AN INDUSTRIALIZATION FUND

UGANDA MANUFACTURERS ASSOCIATION partner with **UGANDA DEVELOPMENT CORPORATION** on establishing an Industrialization Fund (IF) for setting up factories in Northern Uganda, Southern Uganda, Central Uganda, Eastern Uganda and Western Uganda (Five Factories Annually) and subsequently work with Capital Market Authority (CMA) on selling ninety percent (90%) of the factory shares to the public on an open market, five percent (5%) shares to NSSF and retains five percent (5%) shares on condition that Uganda Investment Authority directs Uganda Revenue Authority to publish in the media all imported goods /

services which are not locally manufactured / provided with incentives for the domestic entrepreneurs to manufacture/provide them locally so as to create more savers, jobs, members, taxes and wealth. Ministry of trade and industries invite value adding small businesses which are certified by UNBS for an annual capacity building exhibition on condition that you buy products from each exhibitor and distribute them amongst the participants/delegates in the best interest of BUBU (buy Uganda, build Uganda).

25.ERASING COLONIALISM BONDAGE FROM AFRICANS

African Governments stop issuing National I.D cards, Driving license, Passports, academic transcripts etc. to Africans who have colonial names so as to spiritually and emotionally disconnect Africans from the bondage of colonialists to an extent that Africans whose National I.D cards, Driving license, Passports and academic transcripts carry the names of colonialists should be given an ultimatum to drop/abandon the colonial name were also GMOs BLEACHING and LGBTQs should as well be forbidden by African culture and Africa constitution. Africans who bleach are anti-Africa because they wish they were born white instead of black

26.PROMOTE TOURISM, SPORTS AND TRANSPORT THROUGH MUSIC

- **UGANDA AIRLINES** negotiate with each local music artist to organize for his or her fans a get together **BEACH** and **BUZZ** party in any foreign country of your choice on condition that the fans use the boarding ticket of Uganda airlines as entry ticket to the party as Ugandans living in the Diaspora buy brand airline caps and Hoodies as entry ticket.
- **NDERE TROUPS** and **UGANDA NATIONAL CULTURAL CENTER**, mobilize Ugandans for the Annual Cultural Dance Completions and Traditional Crafts Exhibition of but not limited to baskets, music instruments, mates, dressing, knives etc.
- **UGANDA AIRLINES** and **UGANDA TOURISM BOARD** collectively conduct an Annual Diaspora Wildlife Tour (ADWT) for Ugandans who returns home with a foreign friend (s).
- **UGANDA NATIONAL MUSICIANS FEDERATION AND UGANDA MUSICIANS ASSOCIATIONS** mobilize African Music Artist throughout all African countries for an Annual Africa Music Concert (AAMC). Annually award organized music artists who have a well-equipped office with a human resource structure in respect of the vision and mission of UNMF. And also compile one English song about African from each African country including (Born in Africa by Philly Bongole Lutaya and All We Need is Here in Africa by P.J. Powers) that were sang in each African country.
- **UGANDA RAILWAYS** sponsor friendly sports matches in various parts of the country on condition that the fans use the train boarding ticket as entry ticket to watch the matches.

27.NATIONAL BUS OPERATORS MEDICAL, TAX AND SAVING FEDERATION

Government invite bus operators for consultation of creating a National Bus Operators federation (NBOF) which manages all bus parks countrywide, provides medical insurance to the drivers and conductors, enforce tax compliance amongst operators and emit drivers/conductors saving to NSSF on condition that the land titles of all parks are transferred in the name of NBOF were the non-tax revenues from the parks are deposited on the bank account of NBOF. It should be a policy for any driver of public passenger bus to be approved by NBOF on top of wearing the federation uniform while on duty. Anyone found driving without a permit or violating traffic rules or overloading or over speeding or recklessly driving to be automatically sentenced for a one-year hard labor jail sentence without remission or to pay a fine which is a quarter of the value of his or her vehicle or to BOTH serve the sentence and then pay a compensation afterwards if he or she is a habitual violator of traffic rules.

28.AFRICA AFGHANISTAN AND PALESTINE GESTURE OF HOPE

FIRST LADY JANET MUSEVEN and **Queen Sylvia Nagginda** mobilize African countries to grant free education to Afghanistan girls through Public–Private Partnership with Arab Companies as a gesture of hope to Afghanistan girls and to grant dual citizenship to Palestine migrants. But there is also need for government to set up a national academic database where employers can log on to verify the authenticity of an applicant's transcript because there are many people with fake transcripts.

29.PRISON COMPANY

- **Uganda Police Force (UPF)** buy mini-van for transporting suspects to court instead of packing them under the patrol seats as chicken. For UPS and UPF to reduce on the cost of transporting suspects/prisoners to and from court there is need for all Central Prisons to have semi-detached magistrates court and High Court on condition that the current magistrates courts are converted into police stations hence reducing the risks of suspects/prisoners escaping.
- **Uganda Prisons Services (UPS)** allow rich prisoners with long term sentences to sale at least sixty percent (60%) of their sentence to poor prisoner (s) with short term sentence upon negotiations between the two parties before the officer in charge of prison and the magistrate/Judge seal the deal on condition that the rich prisoner meets all the tax charges and legal charges of the transaction. Create a Prison Farm Holding Company (PFHC) which holds all prison farms and sale forty percent (40%) shares of the PFHC to international farming companies so as to maximize the potential of prison farms. And given the high rate of idle labor of remand prisoners yet government spends heavily on feeding and treating them, there is also need for the PFHC to import commercial work into remand prisons which make them busy while earning.
- **Office of the Prime Minister (OPM)** fast-track karamojongos development by nationalizing the land in karamoja region, sentence karamoja warriors/cattle rustlers to a minimum jail term of ten plus years in prisons outside kalamoja region for

attitude change, transfer all teenage kalamojongs to state owned boarding schools outside karamoja region to study from there and to stay there during holidays for deprogramming, appoint adult female karamojongs to plant potatoes, beans and cassava for sale to Namalu Prison Farm as debt without giving them seeds etc. put out of action all the warriors/cattle rustlers who resist arrest. And sell the land to domestic investors/entrepreneurs on condition that each investor/entrepreneur who buys the land adopts a teenage Karamojong from the state-owned boarding schools.

Otherwise, are government's priorities misplaced? It is unfortunate that I watched and observed in February 2023 that the giant store of Namalu Prison farm which government uses to give out free iron sheets, beans, tarpaulins, maize flour and seeds to kalamojongs is in front of the junior prison staff barrack whose windows are roofed with grass. It is because they are in the remote area where most informed ordinary people don't see? I also noticed that prisoners in local prisons like Ntwetwe prison earn UGX-500 per day whenever they are hired to go out for work and when they are done with their sentences, they get all their wages. But prisoners in main farm prison like Namalu prison earn UGX-100 per day and when they are done with all their sentences, they don't get all their wages even when you were a disciplined hardworking prisoner. Now, is there someone at the prisons headquarters who is capitalizing on the UGX-100 earning scheme because Prisons know when someone is convicted and he/she will complete his or her sentence and if you call former convicts who were not paid their earning scheme, you will be surprised the turnover.

30. NATIONAL SPECIAL HIRE OPERATORS MEDICAL, TAX AND SAVING FEDERATION

Governments invite special hire operators for consultation of creating National Special Hire Operators Federation (NSHOF) which manages all parks and stages countrywide, provide medical insurance to the drivers, enforce tax compliance amongst operators and remit drivers savings to NSSF on condition that the land titles of all parks are transferred in the name of NSHOF where the non-tax revenues from the parks and stages are deposited on the bank account of NSHOF. It should be a policy for any driver of public passenger Special Hire to be approved by NSHOF on top of wearing the association uniform while on duty. Anyone found driving without a permit or violating traffic rules or overloading or over speeding or recklessly driving to be automatically sentenced for a one-year hard labor jail sentence without remission or to pay a fine which is a quarter of the value of his or her vehicle or to BOTH serve the sentence and then pay a compensation afterwards if he or she is a habitual violator of traffic rules.

31. AFRICAN STATION AND DECODER

- Uganda Airlines mobilize and coordinate all state-owned airlines in all African countries to merge into an Africa Airlines (AA) and then sell forty percent (40%) of AA shares to BRICS so as to widen market access, to spread the risks, to fast-track

African federation and to raise more operating capital. And also fine-tune your slogan from (fly the crane to the pearl of Africa) to Fly the Pearl of Africa Crane.

- National Media Group, Uganda Communication Commission, Next Media Group and Uganda Broadcasting Corporation collectively invest in the establishment of an Africa Union Television Decoder (AUTV Decoder) with a phone App which host all TV stations in Africa and then sale the AUTV Decoder in all African countries so as to widen your audience coverage on top of securing government contracts of marketing African countries globally. The AUTV Decoder should as well host radio stations in all African. Alternatively, mobilize state own television station throughout Africa to merge into an Africa Global Broadcasting Network.
- Uganda Railways mobilize and coordinate all state-owned railways in all African countries to merge into an African Railways (AR) and then sale forty percent (40%) of AR shares to BRICS so as to widen market access, to spread the risks, to fast-track African federation and to raise more operating capital.

32. ENACT AN ANIMAL CRUELTY LAW AND IMPARTIAL DEFILEMENT LAW

- GOVERNMENT, given the rate of youths on simple defilement cases in prison for years were the rate of teenage girls sexual immorality is extremely high because of the blank cheque teenage girls have to indulge in sexual immorality (fornication) as they please, there is need to enact an impartial simple defilement law which punish both the teenage girl who indulge in sexual intercourse (fornicate or trades in sex) for material or monetary gains and the male who provides the material or monetary in exchange for sex. Sexually active teenage girls as young as ten years (10 years) indulging in sexual immorality as a result of the environment they are brought up in were also some of their parents permit them to seduce men for material or monetary gains (prostitution) not for getting peer pressure. The law should state that any teenage girl who decides to have sex for material, for pleasure or for money before clocking eighteen years consents to simple defilement hence subject for punishment by courts of law and parents who allow their children to indulge in sex for material gains before clocking eighteen years of age promotes simple defilement. Otherwise, if you invite people who have sons or brothers in prison over simple defilement yet the girl was left at large flying with other men to an extent of getting pregnant, you will be shocked by the large volume of turnout.
- Enacts an animal cruelty laws which penalize truck drivers who load animal/birds on the trucks and tie them in a painful manor which leads them to bleed or die in transit before they reach the market. Otherwise, my GREATEST LOVE will always go out for the welfare of animals, children and birds because there love is genuine to an extent that whatever bad thing they do, it is done in good faith out of ignorance.

33. NATIONAL LORRY OPERATORS MEDICAL, TAX AND SAVING FEDERATION

Governments invite lorry operators for consultation of creating a National Lorry Operators Federation (NLOF) which manages all parks and stages countrywide, provides medical insurance to the drivers and ton-boys, enforce tax compliance amongst operators and emit savings of drivers/conductors to NSSF on condition that

the land titles of all parks are transferred in the name of NLOF were the non-tax revenues from the parks and stages are deposited on the bank account of NLOF. The NLOF should push for the enactment of an animal cruelty law which penalize truck drivers who load animal/birds on the trucks and tie them in a painful manor which leads them to bleed or die in transit before they reach the market. it should be a policy for any driver of lorry to be approved by NLOF on top of wearing the association uniform while on duty. Anyone found driving without a permit or violating traffic rules or overloading or over speeding or recklessly driving to be automatically sentenced for a one-year hard labor jail sentence without remission or to pay a fine which is a quarter of the value of his or her vehicle or to BOTH serve the sentence and then pay a compensation afterwards if he or she is a habitual violator of traffic rules.

- **UGANDA REGISTRATION SERVICE BUREAU (URSB)** partner with domestic commercial banks to award the youths with registered small businesses which have bank account and it should be a criminal offence for anyone to operate a business which is not registered.

services and brands from BRISC countries which help African countries to develop, force their service provision companies to sale fifty percent shares to Africans and also halt selling minerals them and their allies. In fact African Governments need to stop issuing National I.D cards, Driving license, Passports, academic transcripts etc. to Africans who have colonial names so as to spiritually and emotionally disconnect ourselves from the bondage of colonialists to an extent that Africans whose National I.D cards, Driving license, Passports and academic transcripts carry the names of colonialists should be given an ultimatum to drop/abandon the colonial name were also GMOs BLEACHING, and LGBTQs should be forbidden by culture and constitution in African. If such countries are facing oppressive governments or dictatorship regimes mobilize the citizens not to sale or buy anything to or from any serving police officer, politician, Judges, civil servant, MPs, military officer etc. of such a regime or government including not to sale or buy anything from or to their relatives and friends. The mobilization should include Africans living in the Diaspora not to buy any product or service from any Diaspora company were such police officers, politicians, Judges, civil servants, MPs, military officers etc. hold shares or interests until the oppressive governments or dictatorship regimes falls.

39.CONNER TAX DEFAULTERS TO TRADE EVIDENCE

Uganda Revenue Authority ensure that anyone who has a national I.D card has a TIN number connected to their phone number(s) so as to disconnect them automatically from communicating before clearing their income tax. It is unfortunate that there are very few Ugandans who want to pay taxes but many Ugandans stealing taxes.

40.NATIONAL BODA-BODA OPERATORS MEDICAL,TAX AND SAVING FEDERATION

Government invite Boda-boda operators for consultation of creating a National Boda-boda Operators Federation (NBDOF) which manages all stages countrywide, provides medical insurance, enforce tax compliance amongst operators and emit savings of riders to NSSF on condition that the land titles of all parks are transferred in the name of the NBDOF were the non-tax revenues from the stages are deposited on the bank account of NBDOF. The federation should provide refresher riding course, regularly sensitize riders and passengers through talk shows /events /adverts on wearing reflectors/uniform/helmet while on duty. It should be a policy for any rider of public passenger bike to be approved by National Boda-boda Association on top of wearing the association uniform while on duty. Anyone found riding without a permit or violating traffic rules or overloading or over speeding or recklessly riding to be automatically sentenced for a one-year hard labor jail sentence without remission or to pay a fine which is a quarter of the value of his or her vehicle or to BOTH serve the sentence and then pay a compensation afterwards if he or she is a habitual violator of traffic rules.

41.CORRUPTION INVESTMENT OPPORTUNITIES

AUDITOR GENERAL, UGANDA REVENUE AUTHORITY and INSPECTOR GENERAL OF GOVERNMENT work with the Bankers Association to collectively inform

- **voters to identify corrupt properties, corrupt accounts or corrupt assets and contact the IGG in attention to Transparency International (TI) to help them get twenty percent commission (20%) of the recovered property, account or asset because borrowing for consumption and importing for consumption in an environment where tax rates raise as corruption increase is disabling the natural abilities of Africans to apply our minds on a full state of identifying African solutions hence increasing foreign aid and imperialistic tendencies.**
- **Award employees who have worked with an organization/company for years without a dent of corruption.**
- **Constituency residents who follow up government budget allocation of their area. Anyone who reports their bosses, their relatives, their workmates, their friends or their neighbors who evade tax default on taxes including government organizations which don't emit non-tax revenue like funds which Uganda Prisons gets from hiring prisoners to farmers and funds accrued from rented government office space to private users.**
- **Inform employs to sale or buy evidence of tax evasion, embezzled money, money laundering evidence, inflated loans evidence or tax defaulting at a commission fee to motivate the friends, workers or relatives who are within the circles of the culprit to surrender such evidence for monetary gains which they cannot get from the culprit.**
- **Unemployed graduates to identify evidence of academic forgery, ghost employ or unqualified employs and apply for a job swap.**
- **Parliament to enact a law which fines MPs one million shillings (UGX-1m) for each day they fail to attend parliament sittings without a substantial prior notice to parliament.**

Corruption harms the poor and vulnerable, increasing costs and reducing access to basic services, weakens democracy and exacerbates inequality, poverty, and social division, undermines trust in government and damages economic growth. Creates an environment where crime and bribery flourish. And also impedes the ability of states to respond to public health crises or deliver quality education. While professionally competent people have the necessary knowledge and skills to perform their jobs effectively in the best interest of society.

42.TRAFFIC ADVERTISING LIGHTS

Government, Allow companies to advertise on road humps and to install traffic lights with adverts on any trading center, sharp road corners or road junctions of their choice so as to slow down speeding vehicles that cause accidents and to generate more non-tax revenue. And it should also be a policy for any company, person or organization that a sign post of Police Notice like NO PARKING etc. to first apply to Uganda Police Force (UPF) and then pay to Uganda Revenue Authority for the insurance of the sign post.

43. NATIONAL STREET KIDS SCHOOL

- **MINISTRY OF EDUCATION AND SPORTS, Direct Uganda national Sports council to create a National Sports Holding Company (NSHC) which owns all state-owned sports clubs and sports stadiums and sale forty percent (40%) of NSCL shares to the public (funs) through an IPO so as to reduce corruption, incompetence, nepotism, to spread the risks, to increase investments and to promote professionalism and talent in a public-private setting.**
- **Establish a Public School Holding Company (PSHC) which owns all public primary schools, secondary schools, universities, vocational schools and technical schools with a mandate of creating more public schools, manufacturing all scholastic materials, managing all public schools, manufacturing office stationary, renovating all public schools and creating commercial hostels so as to gradually eliminate donor dependency, tame miss-management of education funds, to reduce the cost of education and to create a pool of subsidizing public schools promptly and efficiently.**
- **Direct Primary schools and secondary schools to teach students in an international language, a mother tongue language and an African adopted language. For example, a school in the central region of Buganda should teach students in Swahili, Luganda and English. A School in the western region of Ankole should teach in Swahili, Lunyankole and English. Etc. because it is unfortunate that most Africans think that speaking English is the yardstick of measuring intellectual capability yet even the most stupid American, British etc. does not speak Lunyankole, Swahili, Luganda or Zulu. Instill Pan-Africanism in all primary and secondary school students by reciting Africa Union's Agenda 2063 every Monday morning to Friday morning at the parade.**
- **Set up a National Street Kids School (NSKS) where any child you pick from the streets is taken and when he/she clocks eighteen NSKS transfers him/her to a training school of police, military or prison. But African countries also need to stop coping and pasting child labour policies which treat symptom instead of treating the causes because, my auntie who was working in the stone quarry had five children. But for her to raise UGX - 3,000 or US\$ - 0.79 for buy a kilo of maize flour with silver fish for lunch, she had to smash six (6) buckets of stones at UGX-500 or US\$-0.13 were each bucket takes about four hours to smash. This essentially means that she had to involve her children in the smashing so as to raise enough money for feeding and renting.**
- **Creates an online academic transcript verification portal where employers can log on to verify the authenticity of an applicant's transcript and also sale pre-exam materials to employers who would like to test graduate who apply for jobs.**

44. THREE IN ONE AFRICAN PROVERBS

NATIONAL LIBRARY OF UGANDA partner with Aristoc Book shop on publishing a three in one (3in1) book which translates African proverbs into English, local languages and Swahili and also mobilize Cultural Leaders, Chief Executives, Country Diplomats and Religious Leaders to write an annual leadership poem which carry

their name, photo, title and drop it at the National Library of Uganda to publish them into a Poetic Slot Book Club (PSBC) which will motivate student's leadership on condition that the proceeds from the sale of the PBC are used to for the development of the National Library. But it should be a policy for the best university graduates in Africa who pass on *merit* to be employed by government.

45. PUBLISH A DESERT ISLAND BOOK

CAPITAL FM RADIO publish a Desert Island Book (DIB) derived from your records of Desert Island programs that you have compiled every Sunday for years so as to educate the public about the reality of success marathon.

46. NATIONAL FARMING INVESTMENT AGENCY

Uganda National Farmers Federation and National Agricultural Advisory Services create a National Farming Investment Agency (NFIA) which partner with land owners to plant or rare on condition that that NFIA provides the farming facilities and then share the profits with the land owners after harvesting. Appoints Davis & Shirliff to build automatic irrigation systems in dry place like karamoja etc. which draws water from the ground to fill the reserve tank (s) and automatically sprinkle the garden at night between 08:00pm and 02:00pm. Mobilize commercial Farmers to hire prisoners on reducing the cost of planting, weeding and harvesting their farms or gardens. And Works with Uganda Prison Services to meet the demand of hiring prisoners because by 2021 the number of prisoners in Ntwetwe prisons could not meet the demand of commercial farmers in the area. Farmers who have goats, cattle, sheep etc. use fruit trees to partition, shade and fencing your farms so as to mitigate the effects of climate change while producing surplus fruits. However, the NFIA should gradually sell forty percent (40%) shares to the public through an IPO so as to spread the risks.

47. COMMON INTEREST AWARD

Smart24 TV, The East African Newspaper and Bob FM Radio collectively award tuition to any student who watch, read and listen to business a topic, program and article with common interest on your Radio, in your newspapers and your TV. But there is need for employers to introduce pre-exam for graduate who apply for jobs so as to tame the rate of fake transcripts in society.

48. EMPOWERING YOUR VOTER

Parliamentary and Presidential enact a law which compels all foreign companies like banks, cement manufacturers, breweries, steel manufacturers, insurance, fuel companies etc. including all state enterprises to sale shares to voters through an IPO. To Appoint Policy Researcher Dr. Fred Muhumuza as Minister for Finance, Planning & Economic Development, CEO Amos Wekesa as Minister for Tourism, Wildlife & Antiquities, Political Economist Stephen Biraahwa Mukitale as the Executive Director of National Planning Authority, the Best Urban Studies Professor as Minister for Land, Housing and Urban Development and Tamale Mirundi as

Minister for Ethics and Integrity / IGG on transforming Uganda as Malaysia, UEA, China, Germany and Singapore in respect of promoting meritocracy on condition that you don't arm twisting them to service your personal interests at the expense of National interests. To direct Parliament set up a Parliament Investment Club (PIC) which mobilizes and coordinates constituency members to set up a Constituency Investment Club (CIC) on condition that the PIC holds ten percent (10%) of the CIC were each MP contributes five million shillings (UGX-5m) as share capital to the PIC once during their term of office. To assign all government ministers and Permanent Secretaries a target to achieve each year. And also enact a law which fines MPs one million shillings (UGX-1m) for each day they fail to attend parliament sittings without a substantial prior notice to parliament. Each new MP should contribute capital to the PIC during his or her worthy of constituency then subsequently look into taming interest rates, public administration cost and tax rates. The CIC should stake an award for unemployed voters to play multiparty sports games of winning seed capital of joining the CIC.

49. SENTENCE ANYONE WHO INSULT A REGISTERED FAITH/RELIGION

Government sentence any person who insults a registered religion/faith of other people to a one year hardlabour jail sentence without fine. It is unfortunate that some Pentecostals preach against the Islamic faith as much as the Muslim preaches against the Pentecostal faith yet none of them is an author of religion/faith. On the 15 April 2024 Dithree Group (now Triple D Group) proposed to Kingdoms under Reference No. D3G- 17/15/4/24 that for Africa to formerly attains her own religion/faith just like Islam is headquartered in Saudi Arabia, orthodox headquartered in Russia, Catholics headquartered in Rome, Anglicans headquartered in Britten, advents headquartered in France and Pentecost is headquartered in America/Canada, this is to invite African kingdoms to collectively register a Traditional Faith (TF), publish Traditional Faith Books (TFB), establish a Traditional Faith Temple (TFT) and publish Traditional Song Book (TSB). - Thank you for canceling all the bad agreements which were made between me/us and the material family, paternal family, friends, strangers and relatives.**
- Thank you for fighting for me/us the physical and spiritual enemies.**
- Thank you for cursing and shaming all those who are jealous of me/us.**
- Thank you for leading me/us to where I have to get money of meeting my/our financial obligations and financial aspirations.**
- Thank you for blessing the good work of my/our hands and the good ideas of my/our heads.**
- Thank you for giving me/us profound wisdom, healthy lifespan and profound blessing of living longer, doing business, raising my/our great, great, great grandchildren and hardworking.**

- Given me/us the ability and guidance of pursuing my/our purpose for living and my/our financial independence.
- Thank you for making me/us a great nation / parent / leader / student / entrepreneur / child / politician / wife / economist / innovator / husband / investor etc.
- Thank you for leading me/us through the challenges, turning circumstances around for my/our advantage and your honor and for answering my/our prayers. May your soul rest in eternal peace. Amen.

Every 25 June shall be a special day for the believers to mobilize their friends and relatives to commemorate Nelson Mandela, gracious maternal ancestors, Thomas Sankara, Patrice Lumumba, Kwame Nkrumah, Haile Selassie, Julius Nyerere, Jomo Kenyatta, Kenneth Kaunda, Malcolm X, Kofi Annan, Kangave Ignatius Musazi, Desmond Tutu, Martin Luther King, gracious parental ancestors, Samora Machel etc. To award morally upright neighbors or workmates who have been married for years consecutively without separating including youths who regularly dress decently and to dedicate Africa.

- The Temple shall host group birth day celebrations for congregants who share the same date of birth so as to appease the ancestors and Heroes for the success, welfare and prosperity of the congregants.
- The female Temple leaders shall wear a white Gomesi with awhile the male temple leaders shall wear a white tunic with a.....coat.
- Temple should rear sheep, dogs, doves, goats and cows at its premises which will be fed by the congregants when celebrating their birthdays. The Temple shall provide the congregants with bursaries and scholarships for pursuing African history and Africa tradition.
