CIVIC EDUCATION

YOUR CIVIC RESPONSIBILITY AS A CITIZEN OR A RESIDENCE IS TO DIRECTLY OR INDIRECTLY PARTICIPATE IN THE PUBLIC LIFE OF YOUR COMMUNITY IN AN INFORMED, COMMITTED AND CONSTRUCTIVE MANNER WITH A FOCUS ON THE COMMON GOOD. WHILE YOUR CORPORATE SOCIAL RESPONSIBILITY AS AN ORGANIZATION OR A COMPANY IS TO GIVE BACK TO SOCIETY. HOWEVER RICH, POOR, FAMOUS OR POWERFUL YOU ARE THE FAILURE OF IDENTIFYING YOUR PURPOSE FOR LIVING AS HIGHLIGHTED IN YOUR INTRINSIC VALUES AND USE IT FOR THE WELL FARE OF SOCIETY WILL SOON OR LATE HAUNT YOU EITHER IN GOOD TIMES OR IN BAD TIMES. THEREFORE, THE SOLUTION TO CHALLENGES OR PROBLEM WHICH YOU ENCOUNTER IN YOUR SOCIETY IS EMBEDDED IN EITHER YOUR TALENT, YOUR POCKET, YOUR EDUCATION, YOUR BUSINESS OR YOUR OFFICE. AND THE FOLLOWING BELOW IS TAILORED FOR YOU TO LEAD THE WAY OF FUSING PUBLIC GOOD WITH PRIVATE GAINS.

1) DISQUALIFY YOUR L.C.1 CHAIRPERSON

Tenants boycott shabby office buildings, shopping arcades or residential buildings with mean landlords who don't care about the fancy organization of their buildings. Potters and mansions publish building malpractice evidence on social media. Ghetto residents and slam residents disqualify your L.C.1 Chairperson who does not call for monthly community cleaning, tree planting and protection of wetlands and also tell your fellow citizens not to liter rubbish. Landlords expel duty tenants who disorganize the area and those who inconvenience neighbors with noise (sound pollution). Potters and mansions publish building malpractice evidence on social media. 2) REFUSE ANIMAL CRUELTY AND PASSENGER OVERLOAD

Pedestrians and passengers don't allow the conductor to load extra passages, help traffic police officers to arrest riders and drivers who violate traffic rules or truck drivers who commit animal cruelty by loading animal/birds on the trucks and tie them in a painful manor which leads them to bleed or die in transit before they reach the market. But also, as a passenger or a pedestrian, don't litter rubbish.

3) RAISE CHILDREN WITH MANNERS AND EMPATHY

But also the fact that people buy primarily because of appearance, how your office/employs/shop etc. looks on the outside has more to do with the your products or service to an extent that

also the welfare, attitude and competence of your employs has more to do with the success or failure of your business, company or brand.

9) ORGANIZED MEN AND WOMEN WITH GOOD LOOKS

Any responsible organized man/boy mast have four things on him whenever he is going out of his home. A watch which help you to ride on time, a wallet which contains an I.D Card in that when you get incapacitated on the way they can easy identify you, a pen so that you don't inconvenience other people when writing notes, and a handkerchief which helps you to wipe your sweats or to blow your nose in public. While any responsible organized woman/girl mast have five things on her whenever she is going out of her home. A bag with sanitary pads, an I.D Card, a pen, a handkerchief and a watch on your wrist. However, the good looks of a male or a female can turn out to be a blessing or a curse depending on his or her attitude, value attachment and character. WhatsApp your relatives, workmates, friends, classmates or neighbors to buy or sale evidence of foreign corruption investment, wetland encroachment, tax evasion, deforestation, domestic corruption investment, noise pollution or tax defaulting at twenty percent commission because borrowing for consumption and importing for consumption in an environment where tax rates raise as corruption increase is disabling the natural abilities of Africans to apply our minds on a full state of identifying African solutions hence increasing foreign aid and imperialistic tendencies. Unemployed graduates identify evidence of academic forgery, ghost employ or unqualified employs and apply for a job swap because it is unfortunate that there are very few people who want to pay taxes but many stealing taxes. Alternatively, contact the IGG in attention to Transparency International (TI) to help you apply for the twenty percent commission (20%) of the recovered property, account or asset. But youths don't spend your hard earned commission on liabilities like cars etc. before setting up your formal income generating activity opinion.....because because of public financial intelligence,.....and for purpose of information.

- b) Law firms donate minibus (Drones) for transporting suspects from police to court because the current method of bundling them under the patrol seats is too inhuman to an extent that in case of an accident none of the suspect can survive.
- c) Churches, Government and Mosques educate society about safeguarding against the danger of AI (artificial intelligence) promoting fake miracles, self-medication and false evidence.

The rest, donate medical facilities to public hospitals because some patients die unnecessarily due to lack of facilities. Adopt a child from an orphanage home. 13) INSULATE YOUR PROPERTIES AGAINST RELATIVE AND FRIENDS

Whereas the constitution states that any person who is above eighteen years of age with anything valuable should make a will, most people fear to make a will thinking that it will draw them closer to their grave. Parents (especially fathers) with children who are below eighteen years of age have lost their property and assets to greedy and selfish relatives and friends after death even when they left a will highlighting who takes what. Such children end up suffering as if their late parents dint leave properties or assets. I deposited my national I.D Card and my passport and after four days I came back with UGX-3 million and I paid her the UGX-70,000 and she pleaded that I give her UGX -1 Million out of the cash I had in the wallet to clear her rent arrears on condition that she pays me back in installments. When I explained to her that I had a deficit of UGX -2 Million out of what I expected to meet my financial obligations, she told me that if I have refused I should never come back to her shop. I realized that she has SELFISH ENTITLEMENT ATTITUDE to an extent that she couldn't consider the UGX-50,000 I gave her freely when we met at Kampala road.

18) GENDER BALANCE SHAREHOLDERS

- Male bosses/leaders appoint a female deputy/vice without compromising professional competence and the Female bosses/leaders should as well appoint a male deputy/vice.
- husbands in the modern world were the garden is in the pocket, pay for only rent, fees, meals etc. on condition that your working wives pay for electricity bills, scholastic materials, water bills, snacks, TV bills etc. so as to promote gender equality amongst working class couples because our grandmothers contributed finically for the welfare of their families by tilting the family land which the grandfather bought. The grandfather would sale the harvest and buy clothes for the grandmother and the children including other household properties. Therefore, in the modern world, any WORKING WIFE who says that this is my money with my parents does so from a selfish angle without reasoning and consideration because the fact that her husband also have parents, such a ladies should stay with their parents (without getting married) so as to closely enjoy her money with her parents. There are many weddings but few marriages simply because couples (cohabiting or married) don't collectively contribute towards the success of a project called MARRIAGE and FAMILY yet a successful relationship is where each partner contributes by fifty percent.

19) NAME AND SHAME THEIR RELATIVES, NEIGHBORS AND FRIENDS
